Oklahoma Baptist Homes for Children Statement of Belief (Adapted from the Baptist Faith and Message, 2000)



The Scriptures

The Holy Bible was written by men divinely inspired and is God's revelation of Himself to man. Therefore, all Scripture is totally true and trustworthy.

God

There is one and only one living and true God. He is an intelligent, spiritual, and personal Being, the Creator, Redeemer, Preserver, and Ruler of the universe. God is all powerful and all knowing; and His perfect knowledge extends to all things, past, present, and future, including the future decisions of His free creatures.

God the Father

God as Father reigns with providential care over His universe, His creatures, and the flow of the stream of human history according to the purposes of His grace. God is Father in truth to those who become children of God through faith in Jesus Christ.

God the Son

Christ is the eternal Son of God. In His incarnation as Jesus Christ He was conceived of the Holy Spirit and born of the virgin Mary. He now dwells in all believers as the living and ever present Lord.
